Presentation

The Code for Sustainable Homes is the UK Government's mechanism to enable design for new zero carbon homes by 2016; the technologies and processes can be similar to the mechanisms seen elsewhere in Europe, including Passivhaus principles. BRE are also leading applied research to reduce energy requirements and develop solutions for existing homes. Simon will outline, how BRE are helping businesses use some of these principles to develop a market in the UK.
