

# ERA-NET Bioenergy

Network of national ministries and funding organisations with the aim to implement joint calls for Bioenergy R&D proposals

**Mission:** “Enhance quality and cost-effectiveness of European bioenergy research programmes through transnational coordination and cooperation”

\*\*\* Promote EU collaboration \*\*\* Avoid duplication \*\*\*

## Funding

- EU-FP6 from October 2004 to December 2010
- Since January 2011: self-funded
- Current Partnership agreement (MoU) until end of 2025

# Summary of 14 Joint Calls (1)

- 2006: Small-scale biomass combustion
- 2007: Cleaning of product gas from biomass gasification
- 2008: Short Rotation Coppice
- 2009: Clean Biomass Combustion
- 2010: Sustainable forest management & optimised use of ligno-cellulosic resources
- 2012: Biogas & energy crops
- 2013: Small-scale heat & power production

# Summary of 14 Joint Calls (2)

**2014:** Integrated biorefinery concepts

**2015:** Innovative bioenergy concepts

**2016:** Biobased economy projects focussed on energy use

**2017:** Bioenergy as part of a smart and flexible energy system

**2018:** Energy systems & circular economy

**2019:** Combined biomass valorization

**2021:** Biomass conversion for industrial heat

# Summary of 14 Joint Calls

- 🍃 Total project costs: **over 70 Mio. €**
- 🍃 Total projects funded: **60**
- 🍃 Countries involved so far: **18**

# The bigger picture...

- 🍃 EU aims/visions for decarbonisation and fighting climate change are high but there is a lack of implementation measures
- 🍃 Bioenergy framework conditions in partner countries are increasingly difficult
- 🍃 BUT bioenergy is necessary to complement other, fluctuating renewables (solar, wind) e.g. in order to balance the grid at all times
- 🍃 **Horizon Europe** (no more support for „ERA-NETs“, but large partnerships which can organise calls together  
→ increased opportunity for self-sustained ERA-NETs such as ERA-NET Bioenergy)

- 🍃 ERA-NET partners are always evaluating new opportunities for cooperation and possible new calls.
- 🍃 **ERA-NET Bioenergy is open for new members (funders) interested to join!**
